CHANGE OF COMPANY NAME AND LOGO

The Board is pleased to announce that the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies of the Cayman Islands on 8 September 2014 certifying that the change of English name of the Company from “Incutech Investments Limited” to “DT Capital Limited” and to adopt “鼎立資本有限公司” as the Chinese name of the Company. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 29 September 2014 confirming the Company has altered its name and is now registered under the name of “DT Capital Limited 鼎立資本有限公司” in Hong Kong under Part 16 of Companies Ordinance.


Accordingly, the logo of the Company has been changed to  which will be printed on all corporate documents of the Company with immediate effect.

CHANGE OF STOCK SHORT NAME

With effect from 9:00 a.m. on 9 October 2014, the Shares will be traded under a new stock short name. The English stock short name of the Company will be changed from “INCUTECH INVEST” to “DT CAPITAL”, while a Chinese stock short name of “鼎立資本” will be adopted for trading in the Shares on the Stock Exchange. The stock code of the Company will remain unchanged as “356”.

Reference is made to the circular (the “**Circular**”) of DT Capital Limited (formerly known as Incutech Investments Limited) (the “**Company**”) dated 8 August 2014 and the announcement relating to the poll voting results at the adjourned annual general meeting held on 2 September 2014 (the “**AGM**”), in relation to, among other things, the proposed change of name of the Company (the “**Change of Company Name**”). Capitalized terms used herein shall have the same meanings as those defined in the Circular unless otherwise stated.

CHANGE OF COMPANY NAME AND LOGO

Following the passing of the special resolution approving the Change of Company Name by the Shareholders at the AGM, the Board is pleased to announce that the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies of the Cayman Islands on 8 September 2014 certifying that the change of name of the Company from “Incutech Investments Limited” to “DT Capital Limited” and to adopt “鼎立資本有限公司” as the Chinese name of the Company. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 29 September 2014 confirming the Company has altered its name and is now registered under the name of “DT Capital Limited 鼎立資本有限公司” in Hong Kong under Part 16 of Companies Ordinance. Accordingly, the logo of the Company has been changed to  which will be printed on all corporate documents of the Company with immediate effect.

EFFECT OF THE CHANGE OF COMPANY NAME

The Change of Company Name will not affect any right of the Shareholders or the Company’s daily business operation and its financial position.

All existing share certificates of the Company in issue bearing the former name of the Company “Incutech Investments Limited” shall, after the Change of Company Name, continue to be evidence of title to the Shares and will continue to be valid for trading, settlement, registration and delivery purposes. As such, no arrangement will be made for the exchange of the existing share certificates of the Company for the new share certificates bearing the Company’s new name “DT Capital Limited 鼎立資本有限公司” as a result of the Change of Company Name.

After the Change of Company Name becoming effective, new share certificates of the Company will be issued only in the new name of the Company.

CHANGE OF STOCK SHORT NAME

With effect from 9:00 a.m. on 9 October 2014, the Shares will be traded under a new stock short name.
