## **SUBSCRIPTION OF NEW SHARES UNDER GENERAL MANDATE**

### **THE SUBSCRIPTION**

On 22 May 2026 (after trading hours), the Company and the Subscriber entered into the Subscription Agreement, pursuant to which the Subscriber has conditionally agreed to subscribe for, and the Company has conditionally agreed to allot and issue, an aggregate of 285,700,000 Subscription Shares at the Subscription Price of HK\$0.049 per Subscription Share. The Subscription Shares represent approximately 10.45% of the existing number of issued shares of the Company (excluding the treasury shares, if any) as at the date of this announcement and approximately 9.46% of the total number of issued shares of the Company (excluding the treasury shares, if any) as enlarged by the Subscription.

**Shareholders and potential investors of the Company should note that Subscription Completion is conditional upon the Listing Committee of the Stock Exchange granting approval for the listing of and permission to deal in the Subscription Shares, and is subject to fulfillment of other conditions under the Subscription Agreement. As the Subscription may or may not proceed, Shareholders and potential investors are reminded to exercise caution when dealing in the Shares.**

## **SUBSCRIPTION OF NEW SHARES UNDER GENERAL MANDATE**

On 22 May 2026 (after trading hours), the Company and the Subscriber entered into the Subscription Agreement, pursuant to which the Subscriber has conditionally agreed to subscribe for, and the Company has conditionally agreed to allot and issue, an aggregate of 285,700,000 Subscription Shares at the Subscription Price of HK\$0.049 per Subscription Share. Major terms of the Subscription Agreement are set out below.

## **The Subscription Agreement**

Principal terms of the Subscription Agreement are set out as follows:

- Date:** 22 May 2026 (after trading hours)
- Issuer:** the Company
- Subscriber:** Mass Trade Global Limited, a company incorporated in the British Virgin Islands with limited liability

The Subscriber is a company incorporated in the British Virgin Islands with limited liability and is primarily engaged in investment holding. It is ultimately wholly-owned by Mr. Liu Junda who has extensive experience in fund investment and management and currently serves as the investment director of an asset management company in the PRC and the executive director of another asset management company in the PRC.

To the best of the knowledge, information and belief of the Directors, having made all reasonable enquiries, the Subscriber and its ultimate beneficial owner are Independent Third Parties. As at the date of this announcement, the Subscriber, who was originally introduced and referred to the Company by Bonus Eventus Securities Limited back in 2021, is an existing Shareholder holding 219,457,200 Shares, representing approximately 8.02% of the issued Shares. Upon Subscription Completion, the Subscriber will hold, in aggregate, approximately 16.72% of the issued Shares.

### **Subscription Shares**

Pursuant to the Subscription Agreement, the Company has conditionally agreed to allot and issue, and the Subscriber has conditionally agreed to subscribe for, the Subscription Shares. The 285,700,000 Subscription Shares to be allotted and issued under the Subscription represent (i) approximately 10.45% of the issued share capital of the Company (excluding the treasury shares, if any) as at the date of this announcement; and (ii) approximately 9.46% of the issued share capital of the Company (excluding the treasury shares, if any) as enlarged by the issue of the Subscription Shares (assuming that there is no change in the issued share capital of the Company from the date of this announcement and up to Subscription Completion other than as a result of the allotment and issue of the Subscription Shares).

The aggregate nominal value of the Subscription Shares is HK\$2,857,000.00.

### **Subscription Price**

The Subscription Price of HK\$0.049 per Subscription Share represents:

- (i) a discount of approximately 14.04% to the closing price of \$0.057 per Share as quoted on the Stock Exchange on 22 May 2026, being the date of the Subscription Agreement; and
- (ii) a discount of approximately 16.95% to the average closing price of approximately HK\$0.059 per Share as quoted on the Stock Exchange for the five consecutive trading days immediately prior to the date of the Subscription Agreement.

The Subscription Price was determined after arm's length negotiations between the Company and the Subscriber with reference to the recent trading prices of the Shares. The Directors consider that the terms and conditions of the Subscription Agreement (including the Subscription Price) are fair and reasonable and in the interests of the Company and the Shareholders as a whole.

The aggregate Subscription Price will be payable by the Subscriber in cash upon Subscription Completion.

### **Conditions Precedent**

Subscription Completion shall be subject to the following conditions being satisfied:

- (a) the Listing Committee of the Stock Exchange granting the approval for the listing of, and permission to deal in, the Subscription Shares (and such listing and permission not subsequently revoked prior to the delivery of definitive share certificate(s) representing the Subscription Shares pursuant to the Subscription Agreement);
- (b) the compliance with all applicable requirements under the Listing Rules by the Company in respect of the Subscription;
- (c) all the representations, warranties and undertakings given by the Company in the Subscription Agreement remaining true, accurate and not misleading in all respects;
- (d) all necessary consents and approvals as may be required to be obtained on the part of the Company in respect of the Subscription and the transactions contemplated hereunder having been obtained by the Company; and
- (e) there having been no material breach by the Company of the terms and conditions of the Subscription Agreement before the Completion Date.

The Subscriber has the right to waive all of the above conditions in part or in full, except for conditions (a) and (b), and none of the conditions above is waivable by the Company.

If the conditions set out above have not been satisfied and/or waived (where applicable) (other than as a result of the default of the Company and/or, as the case may be, the Subscriber) at or before 22 June 2026, 5:00 p.m. (the "**Long Stop Date**"), the Subscription Agreement shall cease and determine (save and except for the provisions governing the confidentiality obligations and other miscellaneous provisions which shall continue to have full force and effect) and thereafter neither party shall have any obligations and liabilities towards each other thereunder save for any antecedent breaches of the terms of the Subscription Agreement.

### **Completion Date**

Subscription Completion shall take place on a Business Day after the satisfaction (or, where applicable, waiver) of all of the conditions precedent referred to above, but in any event on or before the Long Stop Date (or such other date as may be agreed by the Company and the Subscriber in writing).

## Ranking

The Subscription Shares, when fully paid and allotted and issued, will rank pari passu in all respects among themselves and with the Shares in issue on the date of allotment and issue of the Subscription Shares.

## Application for Listing

The Company will make application to the Stock Exchange for the listing of, and permission to deal in, the Subscription Shares.

## General Mandate

The Subscription Shares will be allotted and issued pursuant to the General Mandate granted to the Directors at the annual general meeting of the Company held on 23 May 2025, pursuant to which the Directors were authorised to allot, issue and otherwise deal with a maximum of 547,056,000 Shares. As at the date of this announcement, no Shares have been allotted and issued under the General Mandate. As a result, the General Mandate is sufficient for the allotment and issue of the Subscription Shares. Accordingly, no separate approval of the Shareholders is required for the Subscription.

### **Reasons for and Benefits of the Subscription and Use of Proceeds**

The Group is principally engaged in investment holding and trading of securities.

The gross proceeds of the Subscription will be HK\$13,999,300.00 and the net proceeds of the Subscription, after deduction of expenses, are estimated to be HK\$13,899,300.00, representing a net issue price of approximately HK\$0.049 per Subscription Share.

The Company intends to apply the net proceeds from the Subscription for investment in potential projects relating to the digital financial technology (FinTech) and e-commerce digitalization business, or other potential investment projects in different sectors and regions as identified by the Company from time to time. The Directors consider that the Subscription represents a valuable opportunity to raise additional funding for the business operations of the Group. It will not only strengthen the Group's financial position and provide necessary funding to seize the aforementioned investment opportunities, but will also enlarge the shareholders' base of the Company, which may in turn enhance the liquidity of the Shares.

The Directors consider that the Subscription Agreement was negotiated on an arm's-length basis between the Company and the Subscriber and is entered into upon normal commercial terms, and the terms of the Subscription Agreement (including the Subscription Price) are fair and reasonable and are in the interests of the Company and the Shareholders as a whole.

### **FUND RAISING ACTIVITIES OF THE COMPANY IN THE PAST TWELVE MONTHS**

The Company had not conducted any fund raising activities involving the issue of its equity securities in the 12 months immediately preceding the date of this announcement.
